2. Public Comment

Ward 1 resident Irene Marsh addressed the Mayor and Council stating that increased property values were advantageous when selling property, but were a detriment, otherwise, due to the increased tax burden that results from the increased value inferring that it caused residents to move out of the City.

Resident Scott Wilson addressed the Mayor and Council concurring with the previous public comment and proposed tax breaks for longtime residents as well as placing a limit on the escalation of taxes in accordance with the rate at the time of purchase.

Ward 2 resident David Marshall addressed the Mayor and Council in opposition of the process for approving the tax rate and preferred that the tax rate be set at \$0.60 per \$100 or lower.

I move the Mayor and Council set the City of Hyattsville's Real Property Tax Rate for Fiscal Year 2022 (FY22) at \$0.63 per \$100 of assessed value. Mr. Marshall suggested eliminating the newly proposed staff positions under the FY22 budget and placing further responsibility on current staff thereby minimizing personnel and providing more opportunity for the funds to be regenerated into the community.

City Treasurer Ron Brooks addressed the Mayor and Council stating that the Real Property Tax Rate remained unchanged for approximately 15 years and that City revenue had increased due to the increased value of homes. Mr. Brooks detailed the expected revenue and compared it to the estimated constant yield noting that the City's financial position would continue to improve.
